Description

Respecting Choices^{*} **Core/First Steps**^{*} **and Advanced Steps**^{*} **Advance Care Planning (ACP) Facilitator Certification** focuses on the skills needed to facilitate foundational advance care planning discussions with any adult and assisting those with serious illness or frailty in making treatment decisions based on their goals of care. Through small groups, role-playing with group debriefing, storytelling, and self-reflection, participants will hone their interview skills when meeting with the individual or with the individual and agent. Learn about NC Advance Directives and how to assist patients and families with completing Health Care Power of Attorney, Living Will, Advance Instruction for Mental Health Treatment (AIMHT), Medical Orders for Scope of Treatment (MOST) and Do Not Resuscitate (DNR) forms.

The purpose of this course is to assist participants in learning effective communication skills and techniques for facilitating person-centered conversations and completion of Advance Directives.

Who Should Attend?

The program is for anyone who has an interest in promoting Advance Care Planning or End-Of-Life Care in the inpatient, outpatient and community settings.
